## Notes to invoice above

 Within two weeks from receipt of engagement fees and signed documents, Healy Consultants Group will complete Delaware LLC company registration. Before submitting a quality company incorporation application to the <u>Delaware Division of</u> <u>Corporations</u>; our Staff and Client will detail-discuss the important business set up considerations, as detailed on this web page (click link).



- In accordance with the <u>Limited Liability Companies Act</u>, each Delaware LLC must i) appoint a registered resident agent and ii) maintain a legal registered office. As always, Healy Consultants Group will supply these professional services.
- 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices.
- 4. In accordance with <a href="Internal Revenue Service">Internal Revenue Service</a> (IRS) guidelines, each entity which wishes to hire employees in the USA must register for tax by applying for an <a href="Employee Identification Number (EIN)">Employee Identification Number (EIN)</a>. The issuance of this number takes up to 6 weeks. Before USA corporate bank account approval, the bank in-house Legal and Compliance Department need to see an EIN number; and
- 5. Without bank signatory <u>travel</u>, Healy Consultants Group will secure USA multicurrency corporate bank account numbers for our Client. From the moment a complete application is submitted to the USA banks, it will take on average <u>one month</u> to secure multi-currency corporate bank account numbers. In most cases, our Staff will complete the engagement without our Client's travel to the bank branch. When <u>travel</u> is unavoidable, we refund US\$950 to our Client. Multi-currency corporate bank account opening is the most <u>challenging</u> part of the engagement. Consequently, we apply our "<u>guaranteed bank account</u> approval or your money back" policy.

To minimize engagement surprises and align all parties' expectations, I recommend you read <u>this web page</u>, specially the due diligence documentation section. To maximize the probability of bank approvals, Healy Consultants will:

- ✓ prepare a business plan, including annual expected inflow and outflow of funds; and
- contact multiple banks to secure their written confirmation, welcoming a formal multi-currency corporate bank account opening application; and
- weekly follow up with the bankers to aggressively and skilfully secure a timely multi-currencycorporate bank account approval;
