- 4. In accordance to <u>South African Companies Act</u>, every South African company must appoint a tax resisdent <u>public officer</u>. Healy Consultants Group will be happy to act as our Client's public officer; and
- 5. In accordance with the <u>South African Companies Act</u>, before a South African entity hires its first local employee it must first register for <u>Pay As You Earn (PAYE)</u>, <u>Unemployment Insurance Fund (UIF)</u> and Workman's Compensation; and
- 6. In accordance to <u>South African Companies Act</u>, each newly incorporated entity must submit Ultimate Beneficial Ownership filing within CIPC within 10 days of incorporation; and
- 7. Without bank signatory travel, Healy Consultants Group will secure South African multicurrency corporate bank account numbers for our Client. From the moment a complete quality corporate bank account opening application is submitted to the South African banks, it will take on average two months to secure corporate bank account numbers.
