1. 3. This fee is an estimate of government costs payable during your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of government costs include **i)** reserving company name with the [Oficina de Marques del Principat d'Andorra \(OMPA\)](#); **ii)** notarizing the memorandum and petition for incorporation and **iii)** limited liability company registration with the OMPA. 13. Depending on our Client's business and nationality, the Andorra Government may require a special regulatory license to carry on your business in the country.
