Consequently, our Clients should expect the bank account approval period to take up to 4 weeks. Furthermore, global banks now require evidence of proof of business in the country where the corporate bank account will be, including sales contracts or lease agreement;

- 4. This is an estimate of annual license fees a BPFZ free zone company must settle with the Free Zone Authority. Actual fees will depend on the business activity. For transparency purposes, all government fee payments will be supported by original payment receipts and invoices. Examples of government costs include i) company registration; ii) Memorandum of Association and Article of Association attestation fees; iii) the specimen signature and the Board of Resolution preparation and submission fee. Following engagement completion, Healy Consultants Group PLC will refund our Client any excess of funds received over actual Government costs paid. Company licenses are renewable annually after the free zone company complied with the accounting obligations;
- 5. For an active trading company, these annual <u>accounting</u>, <u>audit and tax fees</u> are an estimate of Healy Consultants Group PLC fees to efficiently and effectively discharge your annual company accounting, audit and tax obligations. Following receipt of a set of draft accounting numbers from your company, Healy Consultants Group PLC will more accurately advise accounting and tax fees.
