- 12. There is no minimum share capital requirement in Kazakhstan for a branch office. - 13. In accordance with the <u>Law of the Republic of Kazakhstan on limited liability companies and additional liability companies</u>, each Kazakhstan representative office must have at least one individual branch manager ordinarily resident in Kazakhstan. To efficiently and effectively secure LLP registration in a timely manner, most of our Clients request Healy Consultants Group PLC to appoint a temporary nominee resident branch manager.  - Furthermore, every bank signatory of a Kazakhstan corporate bank account must hold a Kazakhstan work visa.
