Thereafter, this address will be used to receive Government correspondence including i) Annual Tax Return ii) Notice of changes in Belize Company Law iii) Notice of liquidation of foundation. Example of our global banking partners include HSBC, Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;







The banks enjoy ultimate power of approval of foundation bank account applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC' control. What is inside our control is the preparation and submission of a high quality bank application that maximizes the likelihood of approval.
