1. Consequently, there are no hidden fees or surprises or ambushes throughout the engagement. Thereafter, this address will be used to receive Government correspondence;
3. This fee is an estimate of Government costs to complete your Firm's engagement. For transparency purposes, all government fee payments will be supported by original receipts and invoices. Examples of Government costs include **i)** reserving the partnership name with the [Registry of Corporate Affairs](#); **ii)** preparation of a Partnership Agreement and **iii)** applying for trade registration at the [City Council](#) and **iv)** preparation of the partnership seal. Following engagement completion, Healy Consultants will refund our Client any excess of funds received over actual Government costs paid;

Example of our global banking partners include HSBC , Standard Chartered Bank, Citibank, Barclays, Standard bank, ANZ bank, VTB bank, UBS, Credit Suisse;



During the engagement, shareholders and directors documents may need to be translated into the local language before the Government and Bank approves partnership registration and corporate bank account opening respectively. Consequently, our Client should budget for possible additional translation and embassy atestation fees. Either our Client or Healy Consultants can complete this administrative task;
