## Notes to invoice above

- Within <u>3 weeks</u> from receipt of engagement fees and signed documents, Healy Consultants Group will complete Belize trust registration for our Client. Before submitting a quality trust registration application to the <u>Registrar of International Trusts</u>, our Staff and Client will detail discuss the important business set up considerations, detailed on <u>this webpage</u>, and
- 2. This professional fee includes our assistance to prepare a standardized Trust Deed (or "Deed of Settlement"). This document is a written instrument or contractual agreement which describes i) the duties of the trustee, ii) the names of the beneficiaries and iii) the nature and size of assets which are the subject of the trust. To prepare a non-standardized, tailor-made trust deed reviewed by a Belize lawyer additional third-party legal fees will apply; and
- 3. The <u>Belize Trusts Act Chapter 202</u> stipulates each Belize trust shall i) have from the date of its registration a legal registered office in Belize, and ii) to qualify as a Belize International Trust, each Belize trust must also appoint a licensed registered trust agent holding a <u>FSC</u> licence. The trust agent involvement will be limited to annual administration. The trust agent will not i) be involved in the daily management of the trust nor ii) sign legal international contracts nor iii) engage in asset management operations nor iv) be appointed as a bank signatory. As always, Healy Consultants will supply these <u>professional services</u>;

The <u>Belize Trusts Act Chapter 202</u>, stipulates that each Belize trust i) is not required to file the trust deed to the Government, keeping important aspects of the trust deed confidential, ii) is not required to appoint a resident trustee, and iii) the details of the trust are not publicly available on the Belize International Trust Registry; and

Without bank signatory <u>travel</u>, Healy Consultants Group will secure an offshore multicurrency trust bank account numbers for our Client. From the moment a complete application is submitted to the banks, it will take on average <u>three months</u> to secure multi-currency trust bank account numbers. In most cases, our Staff will complete the engagement without our Client's travel to the bank branch. When <u>travel</u> is unavoidable, we refund US\$950 to our Client. Multi-currency trust bank account opening is the most <u>challenging</u> part of the engagement. Consequently, we apply our "<u>guaranteed bank account</u> approval or your money back" policy.

To minimize engagement surprises and align all parties' expectations, I recommend you read <u>this web page</u>, specially the due diligence documentation section. To maximize the probability of bank approvals, Healy Consultants will:

- prepare a business plan, including annual expected inflow and outflow of funds; and
- contact multiple banks to secure their written confirmation, welcoming a formal multi-currency trust bank account opening application; and
- weekly follow up with the bankers to aggressively and skilfully secure a timely multi-currency trust bank account approval;
- 5. This fee is an estimate of <u>Government costs</u> payable during your trust's engagement. For transparency purposes, all Government fee payments will be supported by original receipts and invoices; and

- Effective <u>11 October 2019</u>, all entities registered in Belize engaging in i) holding company activities ii) banking business iii) distribution and service centre business iv) finance and leasing v) fund management vi) headquarters business vii) insurance viii) intellectual property holding and ix) shipping are required to employ local staff and lease a physical office;
