refundable upon de-registration of the entity ii) a medical fitness test of US\$235 and iii) an Emirates ID application and card issuance of US\$165. Before submitting a visa application, applicants must ensure their passport has at least two blank pages and a validity of at least six months. If a visa application is started with the applicant in UAE, the applicant must remain within the country during the process.

If required, Healy Consultants Group PLC will also apply for dependent visas. Our fees will be i) US\$2,950 for a spouse and ii) US\$1,950 per child. Dependent visas can only be applied after the principal sponsor has obtained i) an Emirates ID card ii) a signed lease agreement for a residential property large enough to accommodate all dependents and iii) the Ejari registration for the residential property.

Our visa fees include i) preparation of a quality visa application and ii) submitting the application to the correct government immigration officers. The government enjoys ultimate power of approval over visa applications. Consequently, guaranteed success is outside of Healy Consultants Group PLC's control. What is inside our control is the preparation and submission of a high-quality immigration visa application that maximises the likelihood of visa approval.

16. Some of our Clients require an <u>immediate country solution</u>.
